# FAMILY PROTECTION PROFESSIONAL REGISTRATION PACK

A family protection practitioner is a trained professional who works with all types of vulnerable people, groups, and communities to protect them all kinds of harms. Family protection practitioners tend to work with populations suffering due to poverty, discrimination, or other social injustices.

Professional family protection practitioners aim to create change and encourage the resilience of individuals, families, and communities. This career can be fulfilling for those who enjoy giving back to the community and making a difference in society.

Let's take a closer look at what family practitioners do, why you should consider a career in family protection, and how you can get started.

### What is family protection?

Family Protection is the cultivating of a law-abiding child / citizen to reign in life through mentoring with developed innate creative potentials.

Family protection is "a practice-based profession and an academic discipline that majorly promotes social security and safety and this emanates change and development, social cohesion, and the empowerment and liberation of people," as defined by World Family Protection Association. As a family Protection Practitioner, your primary essence in every immediate community is to educate, counsel and consult on your immediate community's social security and safety.

Family Protection Practitioners are needed in settings such as:

- Hospitals
- Mental health facilities
- Child welfare and human service agencies
- Community development organizations
- Schools
- Halfway houses
- Adoption agencies
- Private practices
- Barracks
- Every home
- Religious gatherings

## Tasks and responsibilities of a family practitioner

Family protection combines many aspects of counseling and traditional human relations while focusing on client case management. Take a look at what types of responsibilities you'll have if you become a family Protection Practitioner in one of these main settings:

- **Family and schools:** Family Protection Practitioners who work with families in the community may advocate for what's in the best interest of a child's upbringing. Family protection practitioners in educational settings work with teachers, students, and families to solve problems impacting children, such as bullying and learning challenges.
- **Health care:** Family Protection Practitioners in medical and public health settings support critically ill patients and their families by helping them find resources and health care needs. Geriatric social work is a growing need in health care because of the rapidly aging population, as it is now in all nations.

**Substance use disorder:** Family protection practitioners in mental health and substance use disorder settings assist patients with therapy and finding financially available rehabilitation. Family protection practitioners may also work in the community to participate in outreach and preventative programs related to substance use disorder.

### Family protection practitioner skills and knowledge

Depending on where you work, you will need specific skills and knowledge relevant to the population you are working with. Building a strong foundational skill set will empower you to help others in the most effective way possible.

Set yourself up for success by building the following <u>interpersonal skills</u>:

- **Communication skills** help you form relationships with people so you can gather information about their challenges. This includes <u>active listening</u>, setting boundaries, and <u>effective communication</u>.
- **Empathy** equips you to understand how another person feels about a situation.
- **Critical thinking** helps you to objectively analyze information about a client's situation based on observations, interviews, and research.
- **Organizational** and <u>time management</u> skills are necessary to manage and document complex cases and the many needs of multiple clients.

• Self-care techniques empower you to maintain a healthy work-life balance in what can be an emotionally demanding field.

As you earn your degree and progress in your career as a family protection practitioner, you'll build more specialized knowledge targeted toward your day-to-day work:

- **Core frameworks** of family protection create the foundation to help you understand ecological systems, social justice, cultural humility, and other practices that define populations.
- Active and reflective listening skills equip you to engage in meaningful conversation with someone to understand their thoughts and allow for effective problem-solving.
- **Interviewing and counseling techniques** include a range of approaches used with clients to help them understand how they can make desired changes in their lives.
- **Client's Critical Assessment (CCA)** is a tool used to assess a client's profile, spectrum status or condition.

# Family protection practitioner job outlook

Professionals with Licensed Research and Experience training and interested in mental health can look into becoming a <u>therapist</u>. Within talk therapy, there are many traditional human relation modalities that you'd work with that require specialized training, but this can also be a fulfilling and well-paid career (depending on your type of certification and qualifications).

# How to become a family protection practitioner

As you pursue a career in family protection, you can choose whether to work in a clinical or nonclinical capacity.

As a non-clinical family protection practitioner, you can offer job, career, and academic counseling services or work on policies that affect welfare and social assistance. Counseling and consulting entry-level administrative roles typically require a Licensed Endorsed research and experience (LRE) registration with World Family Protection Association.

As a clinical family protection practitioner, you require specific knowledge to handle many difficult situations, including substance abuse counseling and support, family abuse cases, and working with patients with post-traumatic stress disorder.

To be a Registered Licensed Endorsed research and experience (LRE) you'll need the following:

- Professional Certificate Family Protection
- Professional Diploma Family Protection
- Three years of supervised clinical research and experience publication
- A license of World family Protection Association to practice

#### Levels of Family Protection Practice (Social Security and safety)

There are typically three different levels of family protection practice. Each of these levels represents the number of people family protection practitioners assist and the basic duties they handle. The three levels of family protection include:

#### Micro

Micro-level family protection directly supports individuals in finding resources to overcome any obstacles or challenges in their daily lives. Those working at the micro level may also hold counseling sessions and work closely with individuals to develop comprehensive plans to improve the conditions of their life and move towards their goals.

#### Those who work one-on-one with clients serve in the micro-level family protection practice

Gerontological family protection practitioner, mental health family protection practitioner and child welfare family protection typically fall under this category.

#### Mezzo

In mezzo-level social work, you support small groups of people. These family protections conduct group counseling sessions, community organizations or treatment groups. When working with community organizations, family protection practitioner may conduct advocacy work, provide family and parenting support, give group therapy, provide mental health support, and encourage chronic illness advocacy. When working with treatment groups, they may assist in addiction counseling, substance abuse counseling, group therapy, and general group support.

Many family protection practitioners operate on both micro and mezzo levels, as they regularly facilitate therapy sessions in both individual and group settings. These individuals typically advocate for broad solutions that address community issues while also providing direct support to small groups. School family protection practitioner, substance abuse family protection practitioner and military and veterans' family protection practitioner usually perform mezzo-level social work.

#### Macro

At the macro level, family protection practitioners assist numerous people to promote and educate individuals on the importance of societal, cultural and community change. Many families protection practitioner who operate on the macro level empower, support and assist local, state, fed, and even international large groups, such as government agencies, non-profits, public service

agencies, universities, advocacy groups, and non-governmental organizations, rather than single individuals or small groups.

Most of their work goes toward improving the treatment of community members and individuals in need. Common fields macro-level family protection includes lobbying, community organizing, community educating, program coordinating, administration and research.

# Types of Family Protection Practice (Social Security and safety services)

# Healthcare or Medical Family protection practitioners

Individuals undergoing medical issues may receive support from family protection practitioner in overcoming these medical challenges and gaining the affordable health care they deserve. They typically work in hospitals or health care facilities. Medical family protection practitioner usually reviews patients' records and coordinate services like therapy and rehabilitation as needed.

They may work with patients' families too to provide education and support regarding the patient's condition. Additionally, these family protection practitioners may collaborate with doctors, nurses, <u>physical therapists</u> and other health care staff to provide the best possible care

<u>What is a Family Protection Practitioner</u>? The first type is those who work behind the scenes, developing services, performing research, and planning policy.

The other type is those who work directly with people in need of care, helping vulnerable individuals and families to navigate their health needs in medical settings.

A healthcare family protection practitioner may be called upon to:

- Assess and diagnose behavioral and mental health.
- Manage patient cases.
- Help patients to access care resources.
- Facilitate advance care planning, hospice, and end-of-life care.

Because they often work in clinical settings.

### Administration and Management, Policy, and Research Family Protection Practitioners

Administration and management family protection practitioner may be able to leverage their expertise to help an array of organizations provide important services. These organizations may include:

• Clinics and healthcare providers

- Colleges and universities
- Government agencies
- Nonprofit organizations

Within their organization, administration and management family protection practitioner oversee various responsibilities specific to their field. These responsibilities may include managing the technical and financial aspects of delivering social services and facilitating the availability of social services within their communities.

They work on a macro level to manage government programs, advocate for individuals in need and build common family protection policies to support community members.

These family protection practitioners typically perform extensive research to understand the common challenges and needs of community members and use this information to inform their policy work. Many family protection practitioners in this field hold an advanced certification like a LRE and gain experience in academic or research settings.

#### Advocacy and Community Organizing

Family Protection Practitioner who tirelessly advocate for and organize social services are an indispensable part of the family protection practice. They perform important roles in working to restore social balance, combat inequality, and ensure social justice.

Often, this type of family protection is done on behalf of nonprofit and grassroots organizations. A community Family Protection Practitioner may be called upon to:

- Advocate for community needs
- Administer or organize neighborhood programs.
- Raise funds and apply for grants.

### Aging and Elderly

Among the many essential services family protection practitioner provide are those which focus on elderly and aging populations. They help elderly individuals and their families in a variety of ways, such as connecting them with public assistance programs or intervening in cases of elderly neglect.

Additionally, this type of family protection often includes:

- Coordinating medical care
- Providing therapy and counseling
- Performing psychological assessments

# Child Welfare

A Child welfare family protection practitioner is focused on helping to build happy, healthy environments for children, adolescents, and their families as a whole.

Child welfare family protection practitioner provides crucial services to help protect these vulnerable populations, such as:

- Connecting families with resources
- Evaluating a child's home environment
- Providing parental education, counseling, and support
- Coordinating care for children and adolescents

These family protection welfare practitioners may also be responsible for removing children from situations where they may be experiencing abuse, neglect, or other kinds of endangerment.

### **International Family Protection**

The need for all different types of family protection practitioner traverses national borders. In nearly all parts of the world, international family protection practitioner serves tirelessly to improve the lives of people no matter where they are.

Frequently, international family protection practitioner serves to resolve issues that affect global communities. They may provide services aimed at:

- Regulating the balance of the biases of human rights
- Aiding refugees and immigrants
- Providing orphan care and placements
- Helping disaster victims

# **Justice and Corrections**

This type of family protection often involves serving individuals within the criminal justice system. The services a justice and corrections family protection practitioner provides may include:

- Serving as an inmate's parole or probation officer
- Providing rehabilitation services
- Assisting with housing and employment after incarceration

On the other hand, justice and corrections family protection practitioner may also provide assistance to victims of crime or to law enforcement officers who have experienced trauma.

#### **Substance Abuse Family Protection**

Substance abuse family protection practitioner may be able to provide invaluable services to individuals who struggle with drug and alcohol addictions, as well as other addictive behaviors. They may provide counseling to families or individuals, help communities develop resources, or work as employment or housing advocates.

Often, this type of family protection happens in places like:

- Hospitals
- Rehabilitation and treatment centers
- Outpatient clinics
- Nonprofit organizations
- Prisons

Because the field of substance abuse often involves mental health care, the responsibilities of a family protection practitioner in this field may overlap with those of a mental health family protection practitioner.

### **Administrative, Policy and Research Family Protection Practitioners**

These individuals typically serve in high-level positions as directors or managers for health care agencies or social service organizations. They work on a macro level to manage government programs, advocate for individuals in need and build common family protection policies to support community members.

This family protection practitioner typically performs extensive research to understand the common challenges and needs of community members and use this information to inform their policy work. Many family protection practitioners in this field hold an advanced qualification like a LRE and gain experience in academic or research settings.

### **Disability Family Protection Practitioners**

These family protection practitioners assist people with disabilities and parents of children living with disabilities. They teach the individuals or the children's parents what their legal rights are and connect them with resources that help the individual meet their needs.

They may help these individuals find comfortable housing, succeed academically and professionally and develop communication and care skills to support themselves effectively. The duties these family protection practitioners perform may vary from client to client, as they adjust their care plans according to the disability of the clients and the unique needs they face.

#### **Political Family Protection Practitioners**

Political family protection practitioners aim to implement change through local, state, and national politics. They may advocate for disenfranchised groups, seeking to minimize the negative effects of racism and economic strife, for example. They typically use their social work background to inform political campaigns, lobbying efforts, or nonprofit missions.

#### **School Family Protection Practitioners**
